



BISMARCK AIRPORT ALLEGIAN AIRLINES FLYAWAY GIVEAWAY OFFICIAL CONTEST RULES AND REGULATIONS

- 1.) Go to Bismarck Airport's website between 8:00 am (CST) on August 5, 2024 and 5:00 pm on August 25, 2024 and enter the Contest using the online entry form provided. The contest will be promoted by Bismarck Airport (BIS) on Social Media, Television, Radio and Online advertising.

Description of the Content: From 8:00am on August 5, 2024 and 5:00 pm on August 25, 2024 the Bismarck Airport (BIS) ("The Airport") is providing a chance to win the following prize package:

- Up to \$1,200 in flight reimbursement from Bismarck Airport to a destination of choice on Allegiant Airlines.
- Up to a \$140 reimbursement for Allegiant Airline baggage fees.
- One (1) week of free parking at Bismarck Airport.

The winner will be responsible for contacting Bismarck Airport staff as noted in the contest rules within the designated time to claim the prize. The \$1,200 in flight reimbursement is good for any destination Allegiant Airlines flies. The flight must originate and terminate at Bismarck Airport. The not to exceed amount of \$1,200 and the not to exceed \$140 baggage fee allotment is in the form of a reimbursement to the winner **after** showing proof of purchase via an itinerary or Allegiant Airlines approved flight receipt listing Bismarck Airport as the departure airport. Air fare in excess of the \$1,200, seat assignments, trip insurance, and any other ancillary airline products are not included in the prize package but can be paid for separately. Contest will be promoted by Bismarck Airport (BIS) on Social Media, Television, Radio and Online advertising. After 5:00 pm on August 25, 2024, the Airport will randomly select one (1) winner from those who completed the required entry form between the prescribed dates and times. The winner will be contacted from the contact information provided on the contest entry form.

4.) Contest forms received after 5:00 pm on August 25, 2024 will be disqualified from the Contest and will not be eligible to win the Prize. The Bismarck Airport (BIS) and all associated parties (including Allegiant Airlines) accepts no responsibility for submissions lost, delayed, damaged, or otherwise not received for any reason. Employees of Bismarck Airport, and their immediate family members are ineligible to participate in this Contest.

5.) All participants must agree to these Official Contest Rules in order to enter this Contest. Entering this Contest constitutes agreement to the Official Contest Rules. Failure to comply with the Official Contest Rules may result in disqualification from the Contest.
